- Coaches seminar – no update

- U12 Girls Coach- Ronnie Storjohann head Ashley Hamilton assistant and Bryan Bahns will also assist
- Tryouts and skills evaluation-handouts-meeting with coaches before- would like input on this and if any one is interested in helping with handouts. Kara can send out flyers to the schools. Historical issues with no coaches for U 8 teams yet. A board member needs to be at every tryout. Ryan Blodig will assist with U8 girls' tryouts. Will need U8 boys' coverage. Emails will come out very soon for coaches to set up their times for assessments/tryouts. Age specific should be at the same time and place.
- First aid triangles are available. Angie has brought them for coaches.

### **New Business (Henry)**

- Uniforms- issues with old uniform being available. We knew this might be an issue. May need to start working with Soccer.com on new uniforms sooner than we thought. I would be willing to work with Kara on this if she is willing. We may be able to limp along for one more season with a comparable uniform to the existing uniform. Need committee to look into uniform selection. Kara would like to give up the uniform portion of her position: soccer.com. Bill Stratman has offered to take over this role.
- Eldridge Park board Goals- How much do we want to donate. The cost is \$1990.00 for Sheridan Meadows for portable nets. Park View goals are in very poor condition and are a possible safety issue, maybe they can be welded together. Schultz Park will need goals in the fall. Donating monies to the city of Eldridge park board will may make us in better position to utilize the fields in the future. \$500 was proposed and agreed upon (motion made and seconded).
- Dates for tryouts and how to conduct tryouts-notice for tryouts once the dates are set. Michael should assist the coaches in conducting tryouts; ask Michael for format. Email to coaches for dates (2 at minimum) for assessment/tryouts. IPSL cannot be before June. Send emails to Sharron Gephart and the board will work together to determine dates. Dates and locations. U10 and below is not a tryout but an assessment. Possibly have one date with individual age groups then have a second date for those who cannot attend. Sessions should be no longer than an hour. 4 v 4 format. Age and gender specific. Henry will place ads in newspaper.
