New Business (Henry)

- Rosters-need information to update rosters. **IPSL must be registered by July 8th. IPSL preliminary schedule is released Aug 6th. Aug 10th schedule changes due, Aug 14th final.**

Season begins Aug 23rd ends Nov 2nd. Illowa registration July 1-31st, season begins Aug 23rd ends Oct 26th. Preliminary schedule Aug 5-15th for U8-12. Scheduling meeting for U 13 and up Aug 16th. Final schedule Aug 17th.

- Uniforms for academy- T-shirts on NSSC website. Kit includes 2 shirts, shorts, socks is approximately \$35. (White and red shirts).
- Uniforms for teams in general-Staying with current uniforms for fall. More than likely we will have to move to new uniforms for spring.
- Fees for teams- i.e. increase for more coaches' pay. Discussion. Should NSSC have a tiered system for paying coaches? Incentive for quality coaches. Motion made for kids who roster only is \$25 (no games, practice only). Motion seconded.
- Academy schedule- Fields, referees and equipment. Do we need more of the smaller goals? David has several sets of pug goals, need for potentially 8 fields for practice. If this is the way the Club is moving, we need to support the Academy. Motion made to purchase the necessary equipment. 8 sets of pug goals, corner flags, items to line fields. Need a meeting with the coaches to identify philosophy of Academy and how this can be done well. Motion made to purchase 4 more goal sets from Bownet 4 x 6 ft. size, cones will be purchased (flat). Motion seconded.
- Academy scheduling-Can we create an actual schedule for the kids and parents to follow? David will work on an actual schedule for the Academy teams. Michael will post schedule on the website for all to reference. Twice weekly practices for Academy teams.
- Academy referees-high school players to assist with refereeing. David would like a designated first aid person at each game day.
- Land committee- meeting up coming. TBA
- Registration for teams – send notice to coaches and managers
- Coaches Clinic- Michael will have a coach's clinic. Emails will go out to find out topics requested and dates. A Saturday in July and Aug, within the next 6 weeks.
- Referee Clinic-Mike Shinbori has sent out emails via Sharron for referee clinics. David is wondering if a 1-2 hour clinic could be set for a simple "rules" session for younger players. Basic sessions would benefit.
- Fees for Academy- What should NSSC charge? Need to cover referee fees and insurance. Discussion to be held once more information has been gathered. An email will go out to coaches.
